AMENDMENT TO DECLARATION OF
COVENANTS, CONDITIONS AND RESTRICTIONS

THIS AMENDMENT to the Declaration of Covenants, Conditions and Restrictions is made and entered into on the dates hereinafter subscribed by FIRST AMERICAN TITLE INSURANCE COMPANY OF ARIZONA, an Arizona corporation, as Trustee, DEGEN DEVELOPMENT COMPANY, a California corporation, d/b/a Degen Development Company of Arizona, GERALD N. DEGEN, and EPIC ASSOCIATES 80-VIII, a limited partnership, by Equity Programs Investment Corporation, general partner (hereinafter referred to as "Owners").

RECITALS:

WHEREAS, the above-referenced Declaration of Covenants, Conditions and Restrictions was recorded on September 12, 1979 in the office of the Maricopa County Recorder in Docket Number 13893 beginning at Page 218, designated Document Number 337190 (hereinafter referred to as "Declaration"); and

WHEREAS, the Declaration was amended by Amendment recorded on May 5, 1980 in the office of the Maricopa County Recorder in Docket Number 14429 beginning at Page 814, designated Document Number 165871 (hereinafter referred to as "Amendment"); and

WHEREAS, the Declaration and Amendment pertain and relate to a subdivision in Maricopa County, Arizona, recorded as HALLCRAFT VILLAS WEST NINE in Book 163 of Maps, Page 48, in the office of the Maricopa County Recorder; and

WHEREAS, Exhibit "A" attached to the Declaration sets forth the legal description of the real property affected by the Declaration (hereinafter referred to as "Real Property"); and

WHEREAS, Exhibit "B" attached to the Declaration sets forth the legal description of the common area affected by the Declaration (hereinafter referred to as "Common Area"); and

WHEREAS, from and since the recording of the Declaration and the Amendment the Owners have determined that it would be preferable to reduce the amount of Real Property and Common Area affected by the Declaration; and

WHEREAS, the Owners have made the decision to reduce the amount of Real Property and Common Area affected by the Declaration in order to reduce the cost, to the Owners and future owners, of maintaining additional improvements which would be constructed within the Common Area; and

WHEREAS, the Owners have determined it would be in their best interest and in the best interest of future owners to reduce the amount of Real Property and Common Area; and

WHEREAS, pursuant to Article XIV, Section 3, of the Declaration, by agreement, ninety percent (90%) the Owners have the right to amend the Declaration; and

WHEREAS, the undersigned Owners represent one hundred percent (100%) of the lot owners within the Real Property.

NOW THEREFORE, for the reasons set forth hereinabove, the Owners amend the Declaration in the following respects:

1. The amount of Real Property affected by the Declaration shall be reduced in size to include only the parcel of real property legally described on Exhibit "A" attached hereto. In accord with the foregoing, the Declaration shall be amended to substitute Exhibit "A" attached hereto for Exhibit "A" attached to the Declaration.

2. The amount of Common Area affected by the Declaration shall be reduced in size to include only the parcel of real property legally described on Exhibit "B" attached hereto. In accord with the foregoing, the Declaration shall be amended to substitute Exhibit "B" attached hereto for Exhibit "B" attached to the Declaration.

3. Except as amended herein and by the Amendment, the Declaration shall remain unchanged and in full force and effect pursuant to its terms.

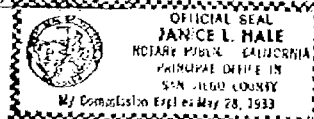

Thence, Northerly along the arc of said last mentioned curve through a central angle of 47°07'38", a distance of 97.88 feet;
Thence, North 03°40'43" West, 153.70 feet to a point of tangency of a circular curve concave to the East and having a radius of 781.00 feet;
Thence, Northerly along the arc of said last mentioned curve through a central angle of 02°00'04", a distance of 26.23 feet;
